Research Methodology:

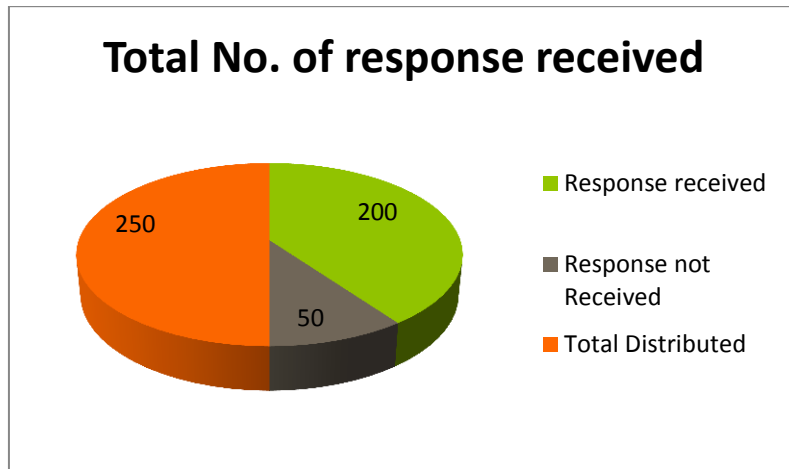

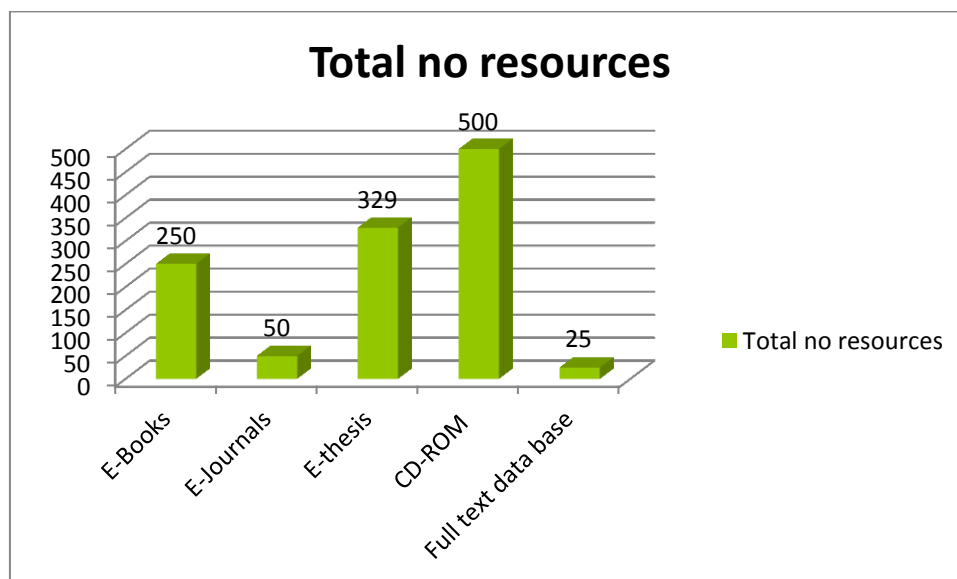


It is found from the above table that 80% response is received from the respondent.

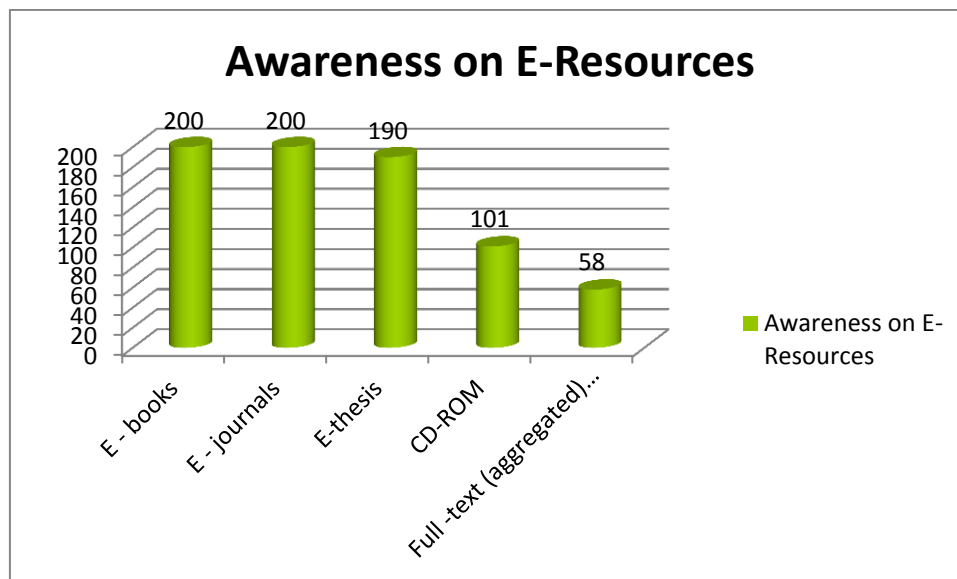

Objective: 2 Awareness to use of electronic resources by users and librarian.

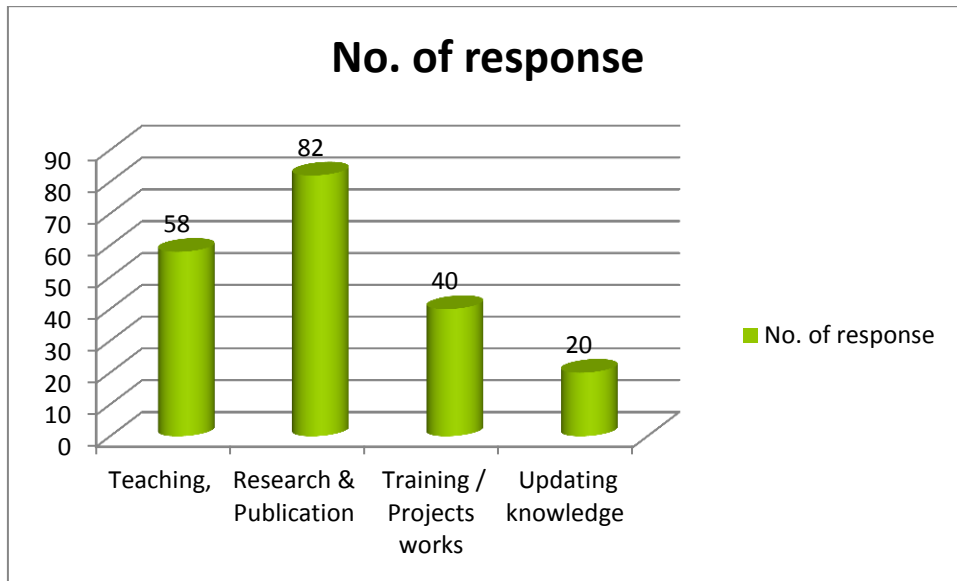

Objective:3 To identify the purpose for using electronic resources.

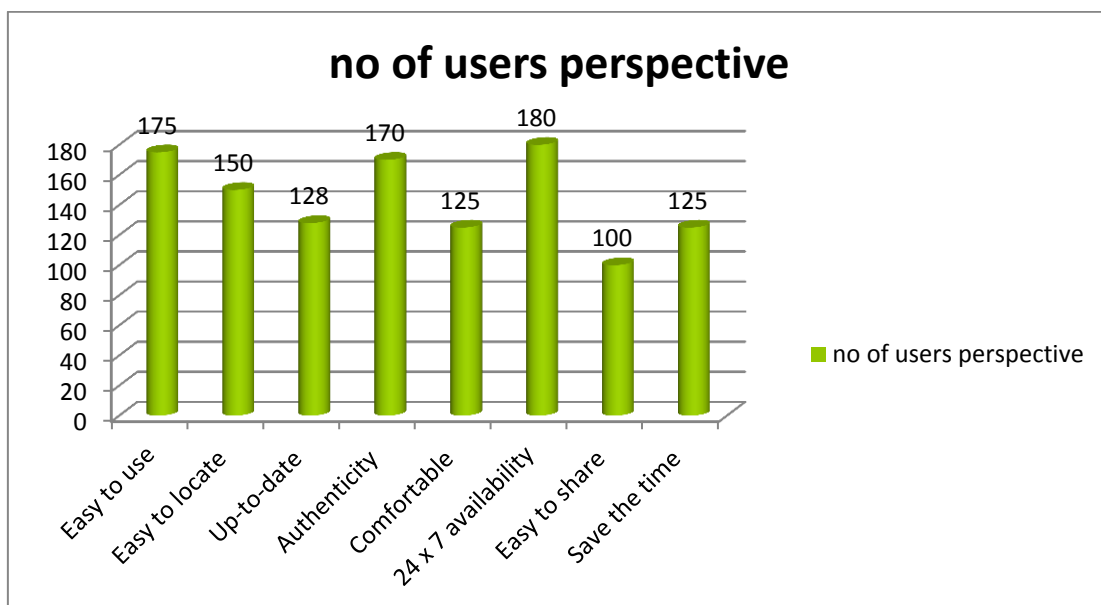

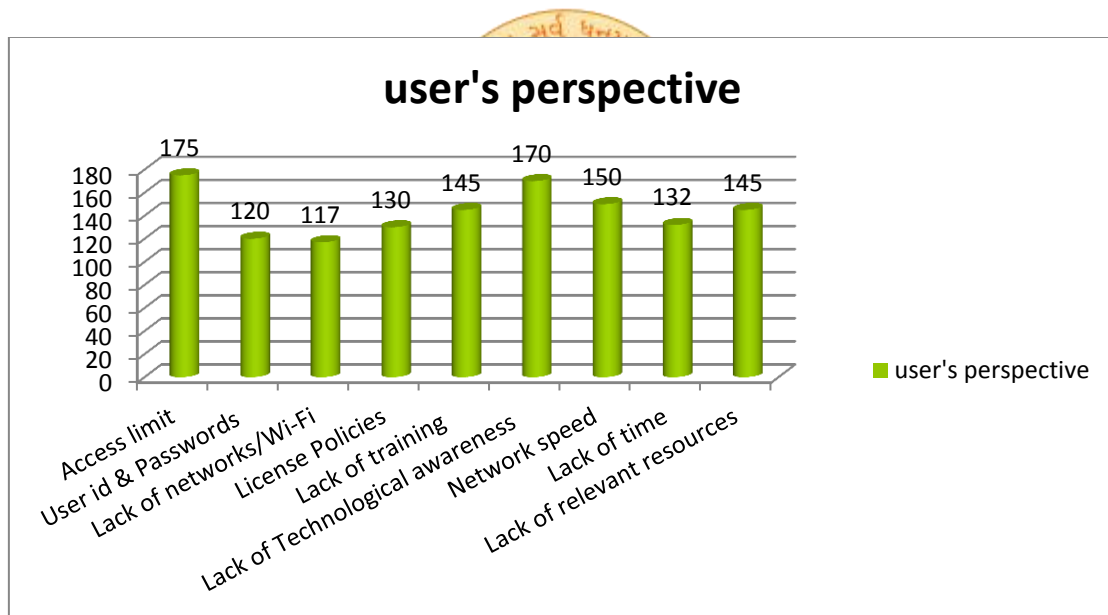
