**Research methodology:**

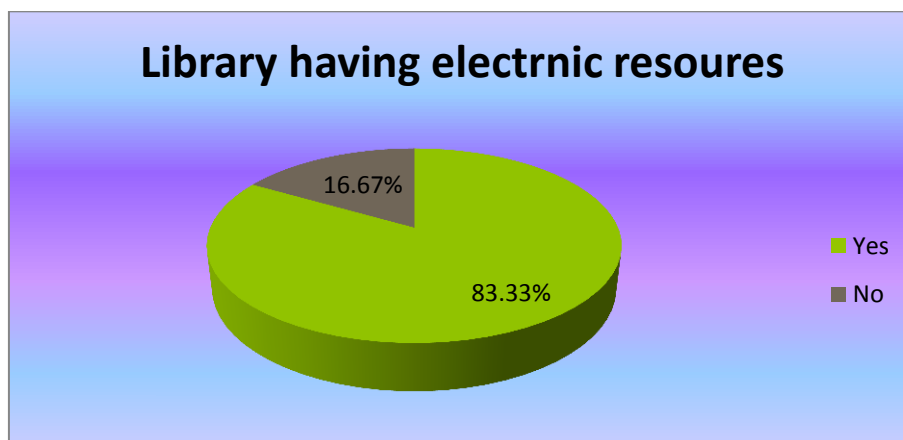

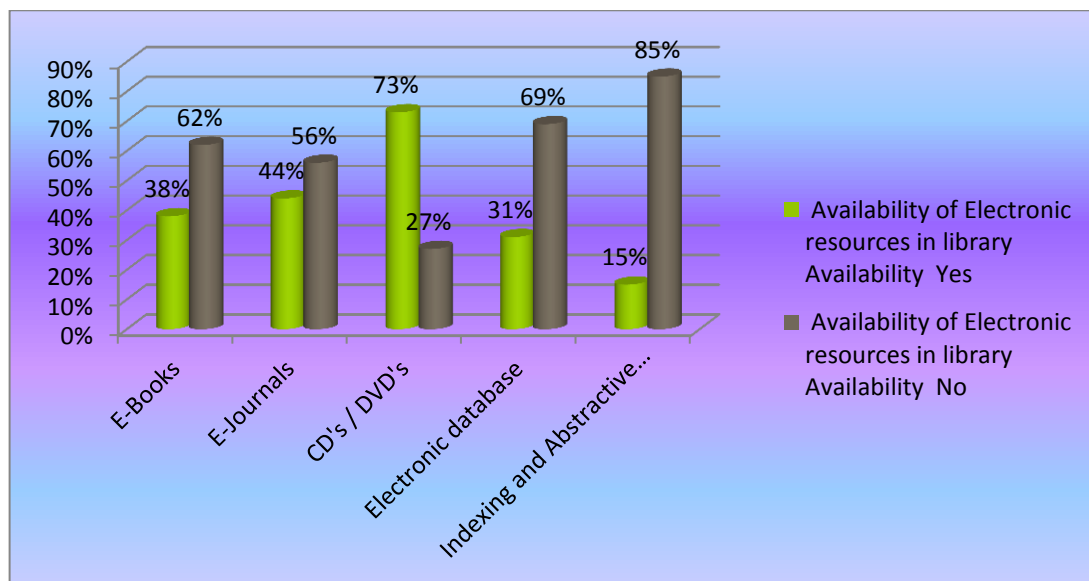

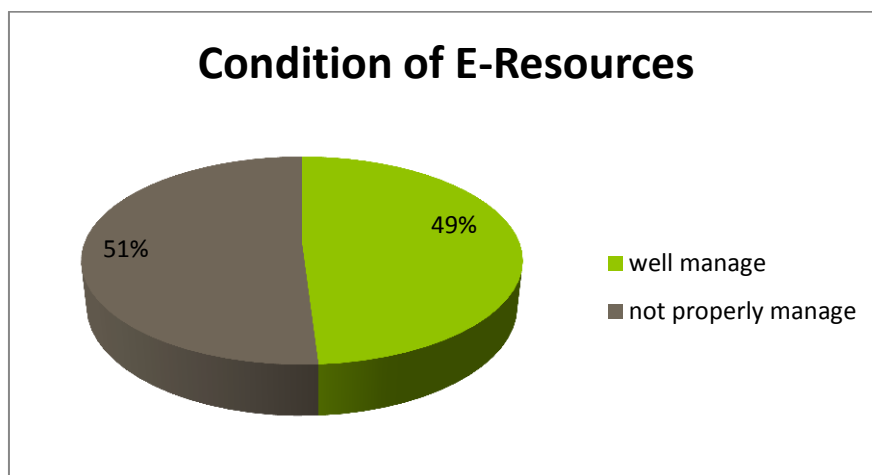

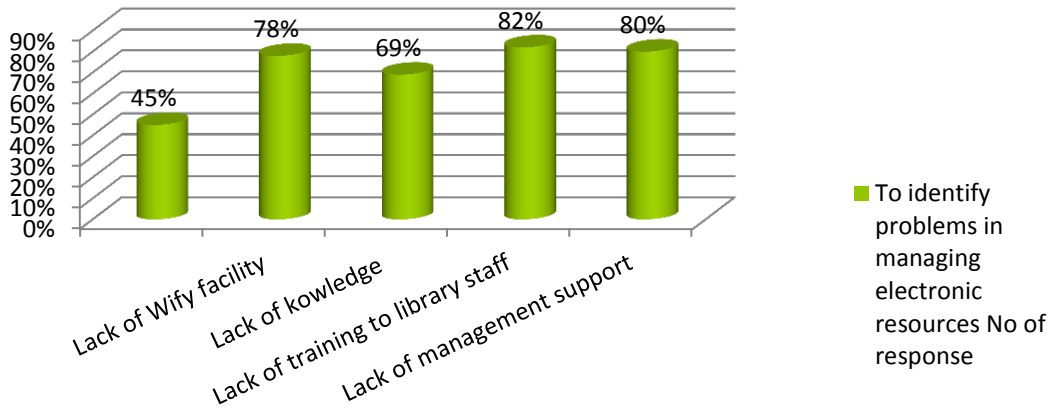
It is found that 49% electronic resources are well managed in the library whereas 51% are not properly manage.

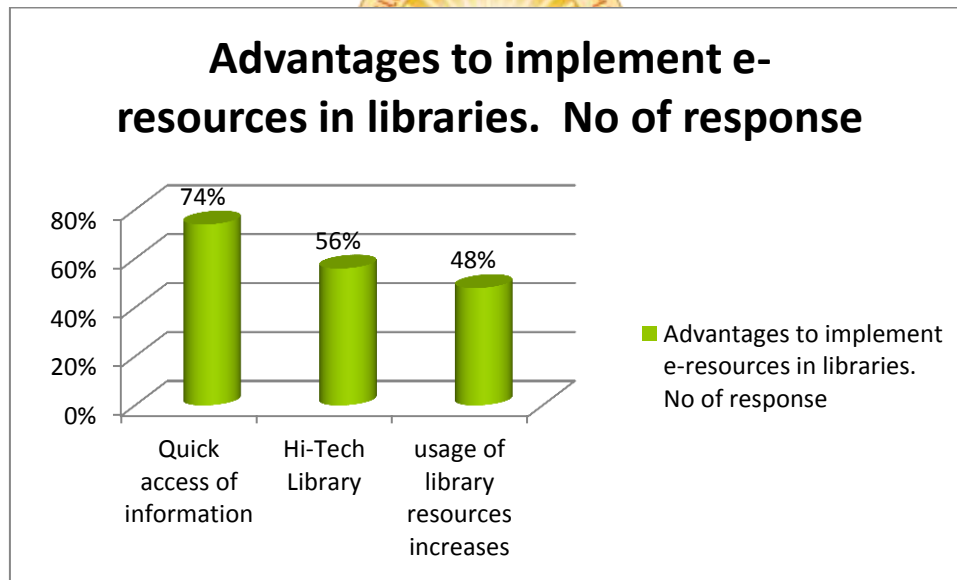
